Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to NRs. 150,000.00 (NRs. One Lakh, Fifty Thousand only), which shall be *valid for minimum 30 days* beyond the bid validity period. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Bank Account of JLTBCL (Deposit Account No. 00100105201107 at Everest Bank Ltd., New Baneshwor) and submit the original receipt of the deposited amount of cash along with the Bid.
- 6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
