- 1. Remit Hydro Ltd. (RHL) intends to develop the project access roads and bridges at necessary crossings for the development of Ghunsa Khola Hydroelectric Project (GKHEP) and Simbuwa Khola Hydroelectric Project (SKHEP) in Taplejung District of Eastern Development Region. RHL intends to procure Consulting Services for all associated works of the Detailed Engineering Design and Preparation of Tender Documents ("the services") for access road and bridges for Ghunsa Khola Hydroelectric Project and Simbuwa Khola Hydroelectric Project.
- 2. The proposed new access road is about 10 km in length and starts from Ghattekhola (initial point of the project access road diverting from the North-South (Dovan-Olanchung Gola Road section) to Lamatar (proposed dam site of GKHEP) via Japantar (proposed powerhouse site of GKHEP) and two permanent bridges over Tamor River (one just upstream of Tamor-Tapmewa confluence for SKHEP and another near Handrung for GKHEP).
- 3. The scope of the Services consists of detailed engineering survey, investigation, design, cost estimate and preparation of tender documents. In particular, the principal activities shall include, but are not limited to the following:
  - Conduct detailed engineering survey, investigation and design
  - Prepare the cost estimate, tender documents and drawings
- RHL requests Expression of Interest (EOI) from all eligible national consulting firms individually or as Joint Venture Partners (JVP) that have qualification and experiences as stated in the EOI document, which can be accessed from the website: <a href="https://www.hidcl.org.np">www.hidcl.org.np</a>.

  Note: Experience and qualification of other firms, whether parent or subsidiary firm, will not be considered for evaluation. Likewise, qualification and experience of the consulting firm

associated as a sub-consultancy will not be considered for evaluation for shortlisting.

- 4. "The Services" of the consultant are required for a period of 9 calendar months in total.
- 5. The shortlisted Consultants shall prepare a technical proposal and financial proposal and shall submitted during RFP (Request for Proposal).
- 6. The consulting firms must provide information on jobs undertaken in the past seven (7) years giving a brief description of each job undertaken and information on the Employer. The firm's experience must be supported by client's/employer's reference.
- 7. Each consulting firm is permitted to submit only one EOI either single or in a joint Venture. Failing to comply with this provision shall prevent the firms from being shortlisted. Firms participating as joint venture must mention the name of the lead partner also.

- 8. The consulting firms will be selected under the Quality and Cost Based Selection (QCBS) method as per the Public Procurement Act 2063 (with amendments) of GON. Three to six highest ranked short listed firms will be invited to submit the Request for Proposal (RFP).
- 9. Brief description and further information of the services and evaluation criteria for shortlisting of the firms can be collected from the address mentioned below during office hours.
- 10. EOI must be delivered in a written from to the address mentioned below during office hours on or before 17:00 hrs. local time on Shrawan 18, 2074. If the dead line falls on a public holiday it shall be extended to the next working day. The submission shall be made in sealed envelope and the title shall be:

#### 1. INSTRUCTIONS TO THE APPLICANTS

#### 1.1 GENERAL

# A. Scope of the Service

Remit Hydro Limited intends to receive Expression of Interest (EOI) from eligible national consulting firms for Detailed Engineering Design and Tender Document Preparation of Access Road and Bridges of Ghunsa Khola Hydroelectric Project (GKHEP) and Simbuwa Khola Hydroelectric Project (GKHEP)- ("the Services") of

- About 10 km long access road for GKHEP that starts from Ghattekhola (initial point of the project access road diverting from the North-South (Dovan-Olanchung Gola Road section) to Lamatar (proposed headworks site) via Japantar (proposed powerhouse site).
- Two Brides over Tamor River (one near Handrung for GKHEP and one just upstream of Tamor-Tapmewa confluence for SKHEP.

The selected consultant shall complete "the Services" within 9 calendar months from the date of commencement of the Services as stated in Contract Agreement.

#### B. Sources of Funds

Remit Hydro Limited, a subsidiary company of Jal Vidyut Lagani Tatha Bikas Company Ltd., will finance the cost for the Services from its own resources.

#### 1.2 ELIGIBLE CONSULTING FIRMS

This call for Expression of Interest is open to all Eligible National consulting firms individually or as Joint Venture Partneres (JV) that have experience in detailed engineering survey and design of:

- At Least two (2) number of new/upgrading district road or higher standard with total of 20 km of length in the last seven (7) years as of the last day of EOI submission.
- At least two (2) numbers of permanent road bridges having span length greater than 25 m in the last seven (7) years as of the last day of EOI submission.
  - <u>Note:</u> Experience and qualification of other firms, whether parent or subsidiary firm, will not be considered for evaluation. Likewise, qualification and experience of the consulting firm associated as a sub-consultancy will not be considered for evaluation for short listing.
- The consultant or a Partner/s of Joint Venture (JV) must not be under a declaration of ineligibility for corrupt of fraudulent practices issued by the Government of Nepal.

#### EVALUATION CRITERIA FOR SHORT-LISTING OF THE CONSULTANT

The consulting firms will be selected under the Quality and Cost Based Selection (QCBS) method as per the Public Procurement Act 2063 (with amendments) of GON. Three to six highest ranked short listed firms with the most appropriate qualifications and references will be invited to submit the Request for Proposal (RFP). Under the evaluation of received RFP the best competitive consultant will be selected for the proposed Services.

All evidences related to the work experience of the consulting firms shall be sufficiently provided. Work experiences shall be evidenced by copies of client's references with contact address on the letterhead of the client's organization and shall be provided in Nepali or English language. The client's reference provided in language other than Nepali and English will not be considered for evaluation.

The evaluation for short-listing of consulting firms will be carried out in two steps.

# 1.3.1 Step I: Initial Screening

In this step, a preliminary screening of all the received EOI proposals will be carried out. The consulting firm needs to meet all threshold criteria as mentioned below to enter into the next step. Any consulting firm that do not meet each and every threshold criteria will be rejected for evaluation.

#### Threshold Criteria

- i. EoI proposal shall be received by the last date and time of submission as mentioned in the Notice of EoI (Published in the edition of Gorkha Patra National Daily dated 2074/04/04).
- ii. Following documents are necessary to be submitted along with EoI by the firm or JV partner/s.
  - Copies of Registration certificates of consulting firm
  - Financial statements or documents to support the annual turnover of the company
  - VAT/PAN certificates
  - Tax clearance certificate/tax submission certificate.
  - Power of Attorney
  - Copy of JV Agreement or memorandum of understanding (MoU) of JV Agreement or intended JV agreement, if applicable.
  - Self Declaration
- iii. The company must not be black listed by Public Procurement Monitoring Office (PPMO)/Nepal.
- The consultant or a Partner/s of Joint Venture (JV) must not be under a declaration of iν. ineligibility for corrupt of fraudulent practices issued by the Government of Nepal.
- In case of joint venture application, the evaluation of firm's capacity will be done ν. collectively, for this purpose the relevant figures/numbers of the each members of joint



venture shall be added together based on the share percentage of JV partners for the service.

#### Notes:


- Consultant fulfilling the requirements stated in threshold criteria A, B and C (if applicable) are considered for further evaluation.
- More than one (1) EOI proposal from a firm or JV partners will not be entertained.
- The total number of consulting firms including the lead firm should not exceed a maximum of three (3) in joint venture.
- Experience and qualification of other firms, whether parent or subsidiary firm, will not be considered for evaluation. Likewise, qualification and experience of the consulting firm associated as a sub-consultancy will not be considered for evaluation for short listing.

# 1.3.2 Step II: Detailed Evaluation of Consulting Firms and Selection of Qualified Firms

#### A. Evaluation Criteria

The consulting firms fulfilling the requirements in step I are further evaluated in Step II. In this step scoring system is adopted to rank the applying consulting firms. A total of 100 marks shall be allocated

#### **B.** Selection of Qualified Firms

In order to be selected as qualified firms each firms should secure at least 50% scores in each criteria. The firms failing to score at least 50% in any of the evaluation criteria of step II will be regarded as unqualified firms. Only top 6 ranked firms qualified in EOI process will be notified in due course of time for the submission of technical and financial proposal i.e., RFP process. During RFP process the consulting firm will be selected in accordance with Quality and Cost Based Selection procedure (QCBS).

# C. Clarification during Evaluation by Remit Hydro Limited

RHL can request the application for any clarification during evaluation. The applicant must provide necessary clarifications by any fastest means of communication as requested at the address given in EOI document/Notice. Failure to provide information essential to evaluate the Applicant's qualifications, or to provide timely clarifications or substantiation of the information furnished, the RHL would be at liberty to declare such applicant as non-responsive and reject the application.

# D. Rejection of EOI Document of Applicant

- RHL reserves the right to accept or reject any or all EOI proposals with or without giving any reason whatsoever and is not liable for any losses to application due to such rejection.
- The consulting firm must satisfy the eligible documents (eligibility criteria) such as valid registration certificate of firm, PAN and VAT certificate and tax clearance certificate/tax submission certificate. Failure to submit such eligible documents will result in rejection of application.
- Furnishing of false or wrong information, document or evidence in the EOI document by any
  firm or joint venture may result in rejection of the EOI document of the firm and their joint
  ventures.
- Every pages of the EOI document should be signed by authorized representative and stamped with company seal. The EOI document without having signature on every page will be rejected and will not be considered for the evaluation.
